

Happy New Year and welcome to the Carbon Farming Group newsletter.

The Emissions Trading Scheme was made into law at the end of September and just over a month later with a change of government it was put on hold and placed under review. In this newsletter you will find out what this means and what else is happening with the carbon market.

EMISSIONS TRADING SCHEME

The emissions trading scheme is now law while at the same time it is under select committee review. As it currently stands, you can still technically apply to participate under the forestry provisions of the ETS. This is because the ETS legislation has not been altered or suspended. However, the details of the ETS are under review and subject to change.

SELECT COMMITTEE REVIEW

A select committee chaired by Peter Dunne has been formed to review the existence of the Emissions Trading Scheme, and to consider alternative mechanisms such as a carbon tax.

Submissions have been called for and are scheduled to close on the 13th of February. It is expected that the select committee will report back to the House in March and any changes to legislation on climate change policy to be passed by Parliament by September 2009.

The Carbon Farming Group will be making a submission to the select committee around the experiences we have had as an independent information provider. Once this submission is complete it will be placed on the website.

CURRENT PROGRAMS

Despite the review there are two forestry programs still in operation which can be applied for, one is the Permanent Forest Sink Initiative (PFSI) and the other is the Afforestation Grant Scheme (AGS), these are briefly described below. PERMANENT FOREST SINK INITIATIVE

This program is targeted towards new forests that will not be clearfelled in the future. This will suit natural reversion of scrub back into native forest and/or the establishment of high value species which lend themselves to selective harvesting. As the policy is currently written you can convert your forest from the PFSI into the ETS once the ETS is up and running.

AFFORESTATION GRANT SCHEME

The AGS is a tender based process for the establishment of new forests on unforested land. The government will retain the carbon rights of the forest for the first 10 years. After this period the landowner can either deforest (clear the land) or enter the ETS or PFSI to claim subsequent credits. Priority will be given to those who will be stabilising erosion prone land.
